ORDER

- 1. By the impugned judgments and orders dated 01.10.2024 and 05.11.2024, the High Court reversed the acquittal and convicted the appellant(s) for the offence punishable under Section 302 read with 34 of the Indian Penal Code, 1860 and sentenced them to undergo rigorous imprisonment for life.
- 2. On the one hand, Mr. Abhinav Bajaj, learned Additional Advocate General appearing for the respondent-State, submitted that the judgments and orders passed by the Division Bench of the High Court are well-reasoned and warrant no

interference.

- 3. On the other hand, Mr. Siddhartha Dave, learned senior counsel appearing for the appellant(s) and Mr. Narendra Hooda, learned senior counsel appearing for the complainant submitted that they are not in a position to appreciate the reasoning given in the impugned judgments and orders.
- 4. We have also carefully perused the impugned judgments and orders.
- 5. In spite of our strenuous efforts, we could not understand the reasoning given in the impugned judgments and orders.
- 6. Apart from that it is a settled principle of law that unless the finding of acquittal recorded by the Trial Judge is found to be perverse and impossible, interference in an appeal is not warranted.
- 7. Be that as it may, from the impugned judgments, it is not clear what weighed with the learned Division Bench of the High Court so as to reverse the findings of the learned Trial Judge. We, therefore, refrain ourselves from making any

observations on the merits of the matter.

- 8. Accordingly, we allow these appeals. The impugned judgments and orders dated 01.10.2024 and 05.11.2024 passed by the High Court of Punjab and Haryana are guashed and set aside.
- 9. The matters are remitted back to the High Court for consideration of the appeals afresh in accordance with law.
- 10. All contentions available to both sides are kept open.
- 11. Pending application(s), if any, stand(s)
  disposed of.
