O R D E R

2. Learned Additional Solicitor General of India, on instructions, informs that the preliminary enquiry by the CBI, in terms of the directions issued earlier, is complete and as per such enquiry, a cognizable offence is made out.
3. That being so, the CBI will register the case under the appropriate provisions of law and proceed to investigate the same.
4. A copy of the preliminary enquiry report be handed over to the learned *amicus* after completion of the search and seizure to enable him to assist the Court on the date fixed, i.e., 16.10.2025.
5. Post the matter on 16.10.2025 before the Bench comprising Hon'ble Mr. Justice Surya Kant and Hon'ble Mr. Justice Nongmeikapam Kotiswar Singh.
