This is an application seeking bail u/s 480 BNSS moved on behalf of applicant/accused Abhinay Jaiswar.

Briefly stated, the grounds on which the bail is sought that the applicant is innocent and falsely implicated in the present case. That the applicant is victim of circumstances as he has been roped in as an accused only on the basis of disclosure statement of co-accused. That the offences alleged against the accused are only punishable upto three years. That trial has not begun and it would take considerable time to commence. That the applicant is a permanent resident of the address which is available with the prosecuting agency. That the entire case is based upon documentary evidences and there is no possibility of tampering the same. That the applicant is not a flight risk. That there is no increment in offence against the accused which shows his involvement in the offence complained of. That co-accused Sachin, Jishan and Manvender Singh are already granted bail and thus, the applicant is also entitled to bail on the ground of parity.

Reply of the IO received.

Submissions heard.

The case is of the prosecution against the applicant is that the cheated amount of Rs. 65 lakhs were received in the account which is in the name of the applicant. However, the mobile number linked with the account is not in the name of the applicant. It is not the case of the prosecution that the applicant has operated the account in question. The co-accused Sachin on the disclosure of whom, the applicant was arrested, has already been granted bail along with other co-accused Jishan and Manvender. The investigation qua the applicant is complete and chargesheet has been filed. The applicant does not have any previous criminal antecedants. The applicant is in custody since 08.07.2025. No purpose would be served by keeping the applicant in further custody. Accordingly, the application is allowed and the applicant Λbhinay Jaiswar is admitted to bail subject to furnishing bail bonds in the sum of Rs. 30,000/-, with one surety in like amount subject to further conditions:

- (1) Accused shall not directly or indirectly make any inducement, threat or promise to any person acquainted with the facts of the case so as to dissuade him/her from disclosing such facts to the Court or to any police officer or tamper with the evidence.
- (2) Accused shall not commit an offence similar to the offence of which he/she is accused or suspected of the commission of which he/she is suspect.
- (3) Accused shall appear before the Court on each date of hearing.
- (4) Accused shall inform the Court whenever he/she changes his/her place of residence.
- (5) Accused shall supply accurate details of communication. Address including phone number at the time of furnishing of bail bond.
- (6) Accused will not leave the country without prior permission of the Court.
- (7) Accused shall join the investigation as and when he called by the IO.

Application disposed off.
