O R D E R

- 1. Heard learned counsel for the parties.**
- 2. The petitioners are inside the jail pursuant to FIR No. RC1242024A0004 dated 09.07.2024.**
- 3. It is submitted that the petitioner in SLP (Crl.) No.**

6438/2025 is a sub-Registrar in Commercial Tax Department. The petitioner in SLP (Crl.) No. 6509/2025 is the daughter in-law of Accused No.2 and the petitioners in SLP (Crl.) Nos. 11781/2025 and 11724/2025 are the nephews of Accused No.1.

4. It is informed that sanction was not taken against the then Chairman, Chattisgarh Public Service Commission.

5. It is alleged that there are 62 witnesses and not 41 witnesses as mentioned. Charges have not been framed and the trial has not commenced.

6. The petitioners in SLP (Crl.) Nos. 6438 of 2025 and SLP (Crl.) No. 6509/2025 are simply the beneficiaries of the paper leak and otherwise are not linked with the leakage of the

examination papers.

7. In view of the aforesaid facts and circumstances, since the petitioners are in jail since 12.01.2025, we deem it appropriate to enlarge the petitioners on bail subject to such terms and conditions as may be imposed by the trial Court including surrender of their passport, if any, before the Trial Court and not to leave the Country without prior approval of the Court.

8. Ordered accordingly.

9. The Special Leave Petitions are disposed of. Pending application(s), if any, shall stand disposed of.
