UPON hearing the counsel the Court made the following  
O R D E R

CONMT.PET. (C) No. 528/2024 in SLP(C) No. 3997/2023

1. Learned senior counsel for the petitioner(s) does not wish to press this contempt petition. The same is accordingly dismissed, as withdrawn.

Rest of the matters

2. Having understood the nature of these matters with the assistance of the learned senior counsel representing the parties, we find that there are two sets of petitions, namely: (i) the matters between two groups of Shiv Sena (a political party) (SLP (Civil) Nos.1644-1662/2024 and SLP (Civil) No.3997/2023), and (ii) the matters pertaining to the groups in the Nationalist Congress Party (NCP - a political party) (SLP (Civil) No.4248/2024, SLP (Civil) No.11820/2024 and SLP (Civil) Nos.7957-7959/2024). There is a possibility of some of the issues being common or overlapping, hence, it is resolved that firstly, the arguments will commence in the Shiv Sena matters, followed by NCP matters.

3. The petitioner(s) side is allocated 3 hours' time, which may be adjusted amongst the arguing counsel. Similarly, the

respondent(s) shall be given 2 hours' time, which may also be adjusted amongst the arguing counsel. The Nodal counsel from both sides (Mr. Rohit Sharma - 9958035522, Mr. Chirag Shah - 9820384770, Mr. Pranjal Agarwal - 9920627181, and Mr. Abhikalp Pratap Singh - 9999770795) will ensure that convenience compilations are prepared, complete and placed on record a week before the commencement of hearing.

4. The matters are ordered to be listed along with SLP (Civil) No.4248/2024 and SLP (Civil) No.11820/2024 on 21.01.2026 to be taken up at 11:30 a.m.

5. The Registry is directed to list the Shiv Sena matters followed by NCP matters in the cause list.
