UPON hearing the counsel the Court made the following  
 O R D E R

1. The petitioner has approached this Court for grant of pre-arrest bail in FIR No.502/2023, dated 22.06.2023, lodged at PS Kotwali Nagar, District Gonda, Uttar Pradesh.
2. At the outset, learned State counsel states that as of now, nothing incriminating material has been found against the petitioner.
3. That being so, the arrest of the petitioner shall remain stayed subject to the condition that as and when required, she shall join and cooperate with the investigating agency for the investigation.
4. At this stage, we are also informed by learned counsel for the petitioner that the petitioner's anticipatory bail application in FIR No.31/2022, at P.S. S.I.T., Dist. State SIT, dated 07.12.2022, is pending before the High Court for a year or so.
5. Having regard to the age of the petitioner and other attending circumstances, it is directed that the arrest of the petitioner, in the above-stated FIR, shall also remain stayed, as an interim measure, till the application for anticipatory bail is decided by the High Court.
6. The High Court is requested to take up the said bail application and dispose of the same as per its own merit.
7. It is clarified that the interim protection granted in the above-stated FIRs shall have no bearing on the merits of the respective cases.
8. The Special Leave Petition stands disposed of in the above terms.
9. As a sequel to disposal of the Special Leave Petition, I.A. No.253373/2025 is also disposed of being not maintainable, with liberty to the petitioner to approach the High Court.
10. The other pending interlocutory applications also stand disposed of.
