Though a huge amount of money was recovered from the custody of the appellant, the fact remains that the charges are yet to be framed and the appellant has been under

incarceration for more than two years and only on that ground, we are inclined to grant bail to the appellant.

Accordingly, the impugned order is set aside and the appellant is granted bail on terms and conditions to the satisfaction of the concerned Trial Court.

The appeal stands allowed, accordingly.
