UPON hearing the counsel the Court made the following  
O R D E R

I.A Nos. 180488, 185553, 179416, 179358, 182340, 288975,  
182238 and 182303 of 2025

Shri Nishant Awana, learned counsel appearing for the State Environment Impact Assessment Authority (SEIAA) submitted on instructions that if the mining leases located in Randhisar Pahari, Churu have been restored in March, 2025, then those applications shall be considered by the SEIAA.

We record the said submission of learned counsel appearing for the SEIAA.

In response to the said submission, learned counsel for the applicants stated that these applications may accordingly be disposed of.

Noting the aforesaid submission, we dispose of these applications by directing SEIAA to consider the applications filed by the applicants for re-appraisal of Environment Clearance issued by District Environment Impact Assessment Authority (DEIAA), whose mining leases were restored in March, 2025.

It is needless to observe that the consideration to be made by SEIAA shall be on the merits of each application and in accordance with law.

The applications are accordingly disposed of.

Further, any other application apart from the applicants, who have approached this Court, whose lease has been restored in March, 2025 pending consideration before SEIAA shall also be considered in accordance with law.

Should the applicants herein or any other applicant be aggrieved by the order to be made by SEIAA, then they may avail of the remedy available to them in law before the NGT or the High Court, as the case may be, and not by directly approaching this Court.
