**ORDER**

1. In this Original Application (OA), the Applicant has alleged that the Respondent No. 4 is proceeding with the construction involving extensive demolition and construction activities inside its office campus for approximately 80 washrooms. Learned counsel for the Applicant submits that this construction activity had started from 22.11.2025 and is continuing inspite of the restriction imposed by GRAP-III and IV. She has further submitted that the Applicant has two-month-old infant daughter who is facing serious health issues and the Applicant is also suffering from allergic bronchitis and is compelled to stay away from his daughter. On account of health complications suffered by the Applicant and the medical expenses incurred on this account, the Applicant has claimed the compensation of Rs. 7,11,000/- in this OA.

2. Learned counsel for the Applicant has further submitted that a complaint was made on *Green Delhi App* launched by the Department of Environment and Forest, Government of NCT of Delhi dated 22.11.2025 but the same is still pending and has not been resolved till now.

3. In support of such submission, she has referred to the screen shots of the *Green Delhi App* on page 55. She has further submitted that the complaint dated 22.11.2025 was also made to the CAQM and thereafter the second complaint on 23.11.2025 was made but no action has been taken by the CAQM till now. In support to the submission that the construction activities are going on at the site the Applicant has placed on record the photographs Annexure A-1 page 32 onwards.

4. The OA raises substantial issue relating to compliance of environmental norms.

5. Issue Notice to the Respondents.

6. Applicant is directed to serve the Respondents and file affidavit of service atleast one week before the next date of hearing.

7. The Respondent No. 3 – CAQM is directed to consider the complaint of the Applicant dated 22.11.2025, carry out the ground verification, ascertain violation and take appropriate remedial and punitive action in accordance with law within a period of 10 days from the date of receipt of a copy of this order. Applicant is permitted to submit a copy of this order along with a copy of the complaint to the Respondent No. 3-CAQM. The action taken report will be filed by the CAQM atleast one week before the next date of hearing.
