**ORDER**

**Anil K. Narendran, J.**

We heard arguments of the learned counsel for the appellant, the learned counsel for respondents 1 to 3 and the respective Standing Counsel for Kerala University of Health Sciences, the Kerala Nurses and Midwives Council and also the learned counsel for respondents 9 to 11.

2. The issue involved in this writ appeal centers around an incident that happened on 15.11.2024 in the 9<sup>th</sup> respondent Institute, which is affiliated with the 4<sup>th</sup> respondent Kerala University of Health Sciences and under the management of the 11<sup>th</sup> respondent Centre for Professional and Advanced Studies.

3. During the course of arguments, the learned Standing Counsel for the University has brought to our notice the provisions under Section 61 of the Kerala University of Health Sciences Act, 2010.

4. We notice the definition of 'student' given in clause (z) of Section 2 of the said Act.

5. On a specific query made by this Court, the learned counsel for respondents 1 to 3-petitioners would submit that 2020-25 B.Sc. Nursing batch completed the course on 24.03.2025.

6. We notice that the appellant, who is the father of the deceased student, got himself impleaded as the additional 9<sup>th</sup> respondent in the earlier writ petition, i.e., W.P.(C)No.45304 of 2024, which was disposed of by Ext.P17 judgment dated 04.04.2025. On a query made by this Court as to the reason for not arraying the father of the deceased as a respondent in W.P.(C)No.30520 of 2025, the submission made by the learned counsel for respondents 1 to 3-petitioners is that it is not intentional.

7. The learned Standing Counsel for the University would submit that the proceedings before the Board of Adjudication for Students' Grievances, in connection with the incident that happened on 15.11.2024 was closed by Ext.P19 order dated 06.08.2025.

8. Having considered the preliminary arguments advanced at the Bar, we deem it appropriate to direct the learned Standing Counsel for the University to make available for the

perusal of this Court the entire files relating to Ext.P19 proceedings dated 06.08.2025 of the Board of Adjudication for Students' Grievances. The learned counsel for respondents 9 to 11 shall make available for the perusal of this Court the files relating to the disciplinary proceedings initiated against respondents 1 to 3-petitioners.
