UPON hearing the counsel the Court made the following  
O R D E R

1. We are not inclined to interfere with the common impugned judgment and order passed by the High Court. However keeping in mind the larger issue concerning illegal admissions affecting the future of the students, it is imperative to make further inquiry about the conduct of the following colleges:

- (1) Ananya College of Ayurved, Kalol.
- (2) Bhargava Ayurved College, Dahemi
- (3) Indian Institute of Ayurved, Rajkot
- (4) B.G. Garaiya Ayurved College, Rajkot
- (5) Global Institute of Ayurved, Rajkot
- (6) Jay Jalaram Ayurvedic Medical College, Shivpuri

2. Issue notice to the aforesaid colleges.
3. The concerned colleges are directed to file a detail affidavit indicating the circumstances in which they have illegally continued the students for the 3<sup>rd</sup>, 4<sup>th</sup> and 5<sup>th</sup> year of the course.
4. In the meanwhile, we also direct the Gujarat Ayurved University as well as the Central Council of India Medicine to constitute a Joint Committee, conduct a detail inquiry and file a detail report. The Committee will be entitled to call for such informations from the students as well as documents from the colleges. We direct that the students as well as the said Colleges will extend full cooperation to the Committee in conducting the inquiry.
