**ORDER**  
**16.02.2026**

1. This is a writ petition filed under Article 226 of the Constitution of India seeking the following relief:

*“a. Issue a writ of Mandamus or any other appropriate writ, order or direction directing Respondent No. 1, Central Board of Secondary Education, to permit the Petitioner to appear in the Class X Board Examination, 2026 with the facility of a scribe/substitute writer;...”*

2. The present petition is filed by the petitioner through her guardian to seek directions against the respondent No. 1, namely the Central Board of Secondary Education (“**CBSE**”) and the respondent No. 3, namely Knewton International School. It is the case of the petitioner that she met with a severe accident and suffered a fracture in her right hand rendering her unable to write Class-X Board Examinations



scheduled for commencement from tomorrow. The representation dated 09.01.2026 made by the petitioner seeking permission to avail the scribe facility before the Principal of the School was rejected on 14.02.2026. Hence, the present petition is filed seeking appropriate directions to allow the petitioner to avail the benefits of the scribe facility.

3. For the said reasons, issue notice.
4. Ms. Dolo, learned counsel accepts notice on behalf of the respondent No. 1/CBSE.
5. There is nobody appearing on behalf of the respondent Nos. 2, 3 and 4, however in view of the urgency of the matter, the present petition is being taken up for hearing.
6. Ms. Dolo, learned counsel for the respondent No. 1/CBSE, who appears through video conferencing mode states that the competent authority has already considered the aforesaid request of the petitioner and has allowed the same granting the scribe facility to the petitioner. Further, an email will also be addressed to the school of the petitioner and the petitioner will be permitted to avail the scribe facility for her Class-X Board Examinations.
7. In view of the fair statement of learned counsel for respondent No. 1/CBSE, the present petition is allowed and disposed of in aforesaid terms.
