1. When the matter is called out, Ms.Saloni Kapadia, learned Counsel, appears for the Applicant and submits that the Execution Application seeks execution of order passed under Section 17 of the Arbitration and Conciliation Act, 1996, and that the Respondents have

been in breach of the said order, and that, therefore, this Court may grant disclosures as well as continue the injunction that has been granted by the Arbitral Tribunal.

2. Ms.Shubhra Swami, learned Counsel, appears for the Respondents and submits that an application under Section 34 of the Arbitration and Conciliation Act, 1996, has been filed and that some time be granted, however, submitting that there is no stay on the execution of the award.

3. Since there is no stay on the execution of the award, this Court is of the view that disclosures be made in terms of prayer clause (a) to the Interim Application.

4. Let affidavit of disclosure on oath in terms of prayer clause (a) be filed and served by the Respondents within a period of four weeks.

5. As requested by the learned Counsel appearing for the Applicant, the injunction granted by the Arbitral Tribunal in terms of the operative part of the award (c) on page 60, the same to continue until further orders.

6. List on **29<sup>th</sup> July 2026**.
  
7. Let office objections to the Commercial Execution Application be removed and registered number be obtained by the next date.
