UPON hearing the counsel the Court made the following

O R D E R

1. Delay condoned.
2. We have heard learned senior counsel for the petitioner(s) and learned counsel for the State of Tamil Nadu.
3. We see no ground to interfere with the impugned judgment(s) of the High Court. The measures directed by the High Court for protecting the elephant corridors need to be given effect. However, the State shall be at liberty to identify the land which is worth acquisition and is not owned or possessed by the tribal communities. In case the State of Tamil Nadu faces any difficulty in the acquisition process, it shall be at liberty to approach the High Court for suitable modification.
4. However, all those petitioners who, by virtue of the High Court judgment, were deprived of their livelihood may approach the State Government for providing some alternative source of livelihood. Such a request shall be considered sympathetically. We, however, make it clear that no commercial activity whatsoever shall be allowed to run in the subject area.
5. The Special Leave Petitions are, accordingly, disposed of with pending application(s), if any.
