2. This order is in continuation of the order dated 28.07.2026 passed by this Court in S.L.P. (Crl.) No.11712 of 2026.
3. Learned Advocate General for the State of Punjab submits that in relation to FIR No.1 of 2017 of STF SAS

Nagar Police Station, Mohali District, Punjab, the prosecution evidence stands completed. Now, the matter is fixed for recording the statement of the co-accused. In so far as the trial *qua* accused Raj Jit Singh Hundal is concerned, it stands segregated.

4. We request and also appoint Mr. Udai Khanna, learned counsel, a practicing Advocate of this Court, as *amicus curiae* (pro bono).
